

You'll notice the thin blue line flag on the truck, which commemorates police officers who died in the line of duty. Hingham borders Weymouth, the city where Sgt. Michael Chesna was murdered by an unarmed person of color two years ago. To honor his sacrifice on the anniversary of that horrific event this is what HFD does.

This evidently upset Max Giarrusso who wrote an email to the Board of Selectmen to complain that it was racist.

Good afternoon Selectmen,

My name is Max Giarrusso, a life-long resident of Hingham and senior at Denison University out in Ohio. Yesterday, while I was driving down Lincoln Street I passed a fire truck that was proudly flying a Blue Lives Matter, thin blue line flag from the reir. Unfortunately, I did not have time to verify that it was a Hingham Fire Department vehicle, or from another town.

The thin blue line flag has undoubtedly become a political symbol, most often used to counter Black Lives Matter and the fight against rampant police brutality. While Hingham is blessed with a remarkable police force and these problems may not be

police force and these problems may not be as relevant to our quiet little town, the symbols are still representative of issues that our country is confronting as a whole.

This fire truck is a vehicle owned by the town for the purpose of keeping Hingham's citizens safe. I do not think it would be appropriate by any means for a public safety vehicle to don such a politically charged flag in place of the American Flag. Given that you all decided it would be inappropriate to fly a rainbow flag on town property- a flag that represents inclusivity of all- I was shocked to see the thin blue line being flown on town property. To many and to you, the thin blue line may represent support for our first responders; However, it is undeniable that to many it is representative of the fight against Black Lives Matter. It is not a matter of intentions, it is a matter of consequences.

I urge you all to investigate whether or not the fire truck that flew this flag was from Hingham, and if so, to call for the immediate removal of the thin blue line flag from the vehicle, and all other town owned property.







F we allow exceptions we run into these issues.






Imagine being a cop and working for such a worthless bloated bag of garbage? Just look at this disgusting slob.

Displaying political material on public buildings and equipment. RE:

Recently, a resident complained that one of our fire engines is displaying the "Thin-Blue-Line" flag. We understand that these flags were purchased to show support for the police after the murder of Weymouth Sergeant Chesna. We condone displaying the flag for that purpose and thank the members of the Hingham Fire Department for showing their respect for their public safety co-workers.

Over the last few weeks, the "Thin-Blue-Line" flags have taken a different political meaning, which might be offensive to some. The Town of Hingham has a long-standing policy that forbids displaying any political messaging, whether it is a candidate's bumper sticker, literature, sign, or flag on Town property. The flags on the engines, therefore, are a violation of this policy and will need to be removed. We have always shared a great working relationship with the police department, and they don't need a sticker, or flag, to realize that we have each other's back during troubling times.

Dear Chief Murphy and Chief Olsson:

After reading the memo you sent to fire department personnel today, I must say that I am incredibly disappointed in the lack of support for the men and women of the Hingham Police Department and law enforcement agencies across the nation. Ordering the removal of Thin Blue Line flags or insignia from fire department vehicles displays an aggressive opposition to the fellowship of police officers, the duties of law enforcement, and disrespect to the courage and ultimate sacrifice made by far too many.

Your memo says, "[that] the "Thin Blue Line" flags have taken a different political meaning, which might be offensive to some." This statement is simply untrue. Since the early 19th Century, the meaning of the Thin Blue Line has been the same—to symbolize the esprit de corps of law enforcement, the courage, and commitment of officers, and to represent the barrier between the law-abiding citizens of America and the criminally inclined. Just as the American flag pays tribute to the American people and our nation's sacrifices to gain independence, the Thin Blue Line, in any form, symbolizes support for law enforcement and pays homage to fallen officers.

The Thin Blue Line is not a political symbol and is not associated with any political group or message. The Thin Blue Line is a representation of the institution of law enforcement and the commitment to upholding the law. The Thin Blue Line is akin to the fire service's Thin Red Line and bugles, the Caduceus symbol of medicine, and scales of justice in law. Thin Blue and Red Line mourning bands have been worn by police officers and firefighters, by the tens-of-thousands, at comrade funerals across our nation – including the funerals of WPD SGT Chesna, YPD SGT Shawn Gannon, and MIT OFF Scan Collier, as a show of respect, honor, and commitment. These same mourning bands were worn at the funerals of the Worcester 6, BFD LT Walsh, and BFD FF Kennedy.

The hard discussion neither of you wants to have is, this:

The "Black Lives Matter" movement is at full-on war with its "Blue Lives Matter" countermovement, but the "Blue Lives Matter" movement of 2020 has no affiliation with the meaning of the Thin Blue Line and its symbology which dates back to the early 1900s. The only connection between the Thin Blue Line and "Blue Lives Matter" is the color blue and its association with the police.

The political matter here is your order to remove Thin Blue Line flags from the fire apparatus. Your order publicly and purposely supports the mission of the "Black Lives Matter" political movement, and in effect, is a political message, which is a severe violation of long-standing Town policy.

Since your memo and order are politically motivated and violate Town policy. I respectfully request you immediately rescind the memo and the order. Furthermore, since the Thin Blue Line flags displayed on the Hingham Fire apparatus were an honorable display of support to law enforcement and respect to fallen officers, with no political affiliation, and are not in violation of Town policy—I respectfully request you immediately display the flags in their previous fashion.

I would welcome the opportunity to discuss this matter with you at any time.

Please let me know when the memo and order have been rescinded, and the flags are displayed.

Chief Olsson insisted that he was only asking for the flag to be removed because it was political.

Dear Mr. Nardo,

I appreciate your letter and your concern. I do not agree with your analysis but I respect your right to voice it.

This issue is solely about following a policy of the not displaying items that are political in nature by a large number of people.

We appreciate the support that Fire Department personnel share for their fellow Police Officers and I confident that was the sole purpose during this stressful period of covid and social issues.

Chief:

Thank you for the quick response. Whether or not you agree with my analysis or not is immaterial; you have made this a matter of policy. The Town's policy expressly forbids the display of political messaging on Town property, both real and physical. The Thin Blue Line is not political.

What political message, organization, or group are you claiming the Thin Blue Line is associated with?

How is the fire apparatus flying a Thin Blue Line Flag any different from the photo of you on Facebook saluting an "Honor and Sacrifice" flag on National Peace Officer's Memorial Day? Both are displayed on Town property, and both support the police.

Nevertheless, you and Chief Murphy are not the adjudicating authority on Town policy. I will be calling for Tom Mayo and the Board of Selectman to have Town Counsel review your memo and order as it relates to Town policy. I will be encouraging both the police and fire department unions to do the same and will offer my professional services to both free of charge.

I am surprised to see you say "we" in your email; when you know your entire department is in an uproar and deeply disturbed by the memo, you signed. Local chiefs are questioning your "unstable behavior," as one put it, and regional police union presidents are contacting you condemning your "reference[ing] a fellow police officer murdered in the line of duty..." and calling for "respect alone for the [officer] and his family." Both HPD and HFD members are very public about their outrage over this matter.

Glenn, you and I have known each other for a long time. You have always been quick to act and side with anyone claiming "victim" – this is not the time. Please consider the impact this memo and order (which are inconsistent with Town policy and a disgrace to the profession) are having on your department.

I will be reaching out to Mr. Mayo and the Board first thing tomorrow.
